Subject:- **NEET UG counselling, filling up of the seats under Economically Weaker Sections (EWS).**
Reference:- **SRO No. 518 of 2019 dated 02-09-2019.**

Notice No. 90-BOPEE of 2019
Dated 11-09-2019

It is hereby notified for the information of the NEET UG candidates 2019 that:-


- i) Government has notified SRO 518 of 2019 dated 02-09-2019 providing for quota for EWS. This SRO shall have effect from 1st November, 2019.
- ii) The eligible and desirous candidates who have qualified NEET 2019 and fall within the Economically and Weaker Sections (EWS) may have their certificates prepared in accordance with the said SRO, which can be issued by the authorities prescribed in the said SRO. The candidates shall have to produce the necessary documents as prescribed in this regard for obtaining the certificates.
- iii) The candidates who have obtained EWS certificates earlier prior to the issuance of the SRO 518 and before its commencement shall have to necessarily obtain a fresh certificate in terms of the SRO 518 dated 02-09-2019. The certificates issued prior to issuance of SRO 518 shall not be treated as valid as the SRO 518 shall come into force w.e.f. 01-11-2019.
- iv) The intake capacity of the three medical colleges has been increased by 85 seats which shall include the seats under EWS (male/female) and other categories.
- v) Similarly intake of two Government Dental Colleges has been increased by 26 seats.
- vi) The counselling for the additional seats provided by way of increase in intake capacity in GMC, Srinagar/Jammu and SKIMS shall be filled up in the month of November, 2019 for which a detailed procedure shall be notified as the Hon'ble Supreme Court has been pleased to extend the time for counselling and admissions till 30-11-2019 in MA No. 1613 of 2019 in writ petition C 76 of 2015 on an application filed by the State of Jammu and Kashmir.
- vii) Subject to the extension granted for filling up of the additional seats under BDS by the Hon'ble Supreme Court, such seats, shall also to be filled up along with the seats falling under MBBS.
